CONDITIONS REGARDING ACCESS TO BUILDING AND CAR PARK

La Direction de la Sûreté Publique de Monaco informs all persons living or working in buildings whose access is mandatory through the check points of the Circuit automobile de Monaco, that they can go there on simple presentation of an **IDENTITY CARD** or **WORK PERMIT** justifying their right (provide a certificate from the employer stating the address of the company if it is not stipulated on the permit).

These different access control points of the Circuit will check the inputs during the circuit is closed :

MONACO E-PRIX – Saturday 06th May 2023 – From 05.00 am 19.00 am until the circuit reopens

MONACO F1 – Thursday 25th May 2023 – From 08.00 am 19:30 until the circuit reopens

MONACO F1 – Friday 26th May 2023 – From 06.30 am 19:30 until the circuit reopens

MONACO F1 – Saturday 27th May 2023 – From 07.00 am 20:00 until the circuit reopens

MONACO F1 – Sunday 28th May 2023 – From 05.45 am 20:30 until the circuit reopens

Reminder : Access authorizations issued on the Condamine sector exclude parking and stopping on public roads.

IMPORTANT Circuit-side buildings with an entrance outside control enclosures maintain open access and are not affected by these measures, except for the following buildings : ALBATROS, BEAU-RIVAGE, BRISTOL, LES CARAVELLES, CASTELLARA, ERMANNO, LE WINCH, PALAIS HERACLES, LE MAJESTIC, LE PANORAMA, PORTO-BELLO, LES PRINCES, LE RUSCINO, LE SARDANAPALE, LE MIRABEAU, LE SHANGRI-LA, LES VILLAS LES AIGLES COLOMBE, MONJOIE and QUAI KENNEDY.
